- Minutes: The minutes of the August 2024 meeting were presented to the council for review.

#### **OLD BUSINESS**

Josephine County Partnership- Kevin asked John to report on a phone call he received from Thomas at Josphine County Solid Waste, who is excited to partner with us on remediation of abandoned cannabis sites in the future. Plans are to get together on a site in the near future. A question was asked as to whether we have the ability to test water for the presence of pesticides. John answered that we will once we get the gas Chromatograph up and running and there is also a lab in California that can do it.

Capacity Building Update and Discussion- Discussion was held regarding nest steps for Non-Traditional Capacity Building. A meeting of the entire Council was set for Saturday, October 1pth from 10am to Noon to brainstorm. Kevin will send out agenda items ahead of the meeting.

## Page Creek Planting

- We will be working with USFS Fisheries Biologist Julia to coordinate planting at the Page Creek project site. Kevin is hoping to talk to Janice about making an event of it, possible involving local fish groups.
- Formal Termination of Temporary Staffing Agreement
  - The temporary staffing agreement of 2022 between the District and Council for Kevin to step in as
    District Manager while the position was vacant is now obsolete and not in use. Kevin suggested it
    be officially terminated.
    - Kevin made a motion to formally end the temporary staffing agreement of 2022 between the IV Soil & Water Conservation District and the IV Watershed Council.
    - o Patty Downing seconded the motion.
    - o The motion carried unanimously.

# STRATEGIC PLAN UPDATE

 We are moving forward on policies and fundraising. It was suggested and agreed that we have a quarterly check-off rather than monthly

- · Staff and partnering agency reports:
  - Kevin reviewed his written report. He wrote a letter of support for the District Roundhouse Grant application. He passed around copies of the Horse Creek project specifications to those inperson attendees for review and discussion.
    - He will be writing one engagement grant, and some capacity grants this upcoming cycle. He has scheduled a meeting with mark Grenbemer of OWEB to discuss strategy.

- Public Comment
  - Kevin added that OWEB has a survey out asking about a shift in grant application cycles by about three months. It could mean a drought of funds for a season. He would not be in favor of it.
